- 5) The License is issued from Fire Safety point of view only and it is valid for **One year** from the date of issue. The Next Renewal date 11.01.2025.
- 6) Fire Drill and Evacuation Drill Should be conducted periodically Along with the local fire Brigade.
- 7) In Compliance to Section 3, 2 of BIS 12459:1988 – Code of Practice for Fire Safety in Cable Regularization, a transparer Fire retardant coating of 1 meter shall be applied on all electrical cables at both sides of termination points in every electrical panel and all the cables in the Distribution Box.
