State Government of Andhra Pradesh others etc. and later judgments.

Further in the event of infringement/contravention or non-compliance of the conditions prescribed by the AICTE during the last approved academic year, the Council shall take further action to withdraw approval to these cases for admission during 1998-99 and the liability arising out of such withdrawal of approval will be solely that management/Trust/Society and/or Institutions.

SPECIFIC CONDITIONS OF APPROVAL OF ADHIYAMANN COLLEGE OF ENGINEERING, DR. MGR NAGAR, HOSUR, DIST. DHARMAPURI - 635 125.

1. A computer laboratory independent to Architecture Department be established with minimum 10 workstations with software compatible to Architecture course.
2. Separate budgetry provision be made to acquire more Architectural books with a separate section in the main library be earmarked for department of Architecture.
3. The Management should facilitate student working in studios after college hour and encourage conduct of co-curricular activities such as zonal NASA, interaction meets etc.
4. The College working hours should be as per the university norms.
5. The syllabus for Architecture should be revised in tune with Council of Architecture recommendation
