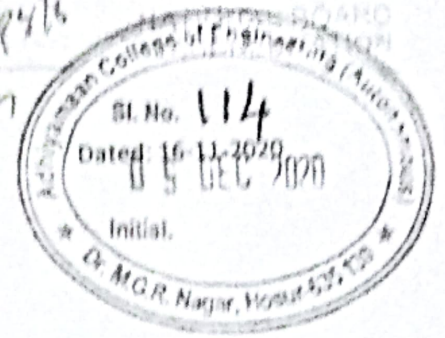

Subject: Grant of accreditation of one year in case of UG Computer Science and Engineering program in Tier-I offered by Adhiyamaan College of Engineering, Dr. MGR Nagar, Hosur-635 109 Krishnagiri District, Tamil Nadu on the basis of Compliance Report.

Sir,

This is regarding Compliance Report submitted by Adhiyamaan College of Engineering, Dr. MGR Nagar, Hosur-635 109 Krishnagiri District, Tamil Nadu for the UG Computer Science and Engineering program which was accredited by NBA in Tier-I for academic years 2017-18 to 2019-20 whose validity has expired on 30.06.2020.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for a period of 3 years upto 30-06-2020 and for which the concerned Institutions have submitted Compliance Reports but their visits for data verification of the programs are pending because of the current pandemic situation due to Corona virus, the programs will be considered for further accreditation of one year i.e. upto 30-06-2021 after data verification of the programs in NBA on the basis of the submitted Compliance Reports. The data submitted by Adhiyamaan College of Engineering, Dr. MGR Nagar, Hosur-635 109 Krishnagiri District, Tamil Nadu in the Compliance Report has been re-considered as per revised norms of NBA and has been examined and verified in NBA. In supersession of NBA's letter of even number dated 15.07.2020, the Competent Authority in NBA has approved the following accreditation status to the program as given in the Table below :

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

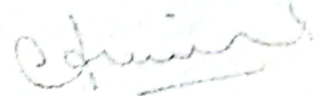

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Adhiyamaan College of Engineering, Dr. MGR Nagar, Hosur-635 109 Krishnagiri District, Tamil Nadu as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.

6. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
