This has reference to your application dated 15-9-2010 seeking accreditation of National Board of Accreditation to various Programmes.

2. An Expert Committee conducted an on-site evaluation of the programmes during 11<sup>th</sup> to 13<sup>th</sup> May 2012 & 18<sup>th</sup> to 20<sup>th</sup> May 2012. The report submitted by the Expert Committee was considered by the Engineering Accreditation Evaluation Committee (EAEC) at its meeting held on 27th August 2012. The Executive Committee of the National Board of Accreditation considered the recommendations of EAEC at its meeting held on 28-8-2012. The Executive Committee approved the accreditation status of each programme of your institution as given in the table below. The Executive Committee has also decided that the duration of accreditation will be academic-year wise. For this purpose the academic year will be considered from July to June. The period of accreditation in col. 4 below has been given accordingly:


3. Accreditation granted is provisional for 2 years. The institution may apply after overcoming the weaknesses to upgrade their status to "Full Accreditation" of the programme.

8. If the institution is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
