

The Committee inspected the Adhiyaman Engineering College on 14.3.93 and the following are the observations:-

1. General facilities:

The general facilities like staff, accommodation, library, laboratory, workshops, equipments etc are quite sufficient for conducting the L year (first year) classes for all the six approved branches. Hostel facilities are already available for 300 men students. The lady students are said to be accommodated in the city. Additional hostels are being constructed.

Regarding the starting of II & III Year classes in the said branches

- (i) II B.E. in Electrical and Electronics Engg (ii) II B.E. in Instrumentation and Control Engg and (iii) II B.E. in Production Engineering
- (b) III 8.E. in Mechanical Engineering (v) III 8.E. in Electronics and Communication Engg (v1) III 8.E. in Computer Science

the following observations are made:-

1) Staff:-

in the dadre of Asst. Professors (atleast one for each branch) are to be additionally recruited in the following areas:

- (i) Electrical & Electronics Engg
- (ii) Instrumentation & Control (iii)Computer Science & Engg
- (iv) Industrial Engg/Production Engg

2) Library:-

Same more books are to be added in the areas of Instrumentation Engg, Mechanical Engg, Production Engg., Electrical and Electronics Engg and Computer Science. Also journals in the above areas are to be subscribed for.

3) Laboratury:-

- (i) for Electrical & Electronics Engg Branch, the machines available in the Electrical machines and transformer Lab are not sufficient. Some more machines are to be added.
- (11) for instrumentation & Control Engg branch, the Thermal Lab is to be augmented. Also Metrology Lab is to be established.
- (iii) for the Production Engg branch, in the Strength of Material Lab one no. Universal Testing Machine (UTM) is to be added.
- (iv) for the Mechanical Engg branch, the facilities in the Thermal Engg Lab are to be augmented. Boiler and Steam Turbins are to be added for conducting experiments in the area of steam. Also a CAD Workstation is desirable to be added for laboratory for project of these atudents.

- . For the Electronics and Communication branch, (v) in Communication thug Lab, I, line communication instruments such as teleprinter are to be Communication Engg Lab II is to be procured. established.
- For the Computer Science and Engg branch, (vi) the Microprocessor Lab II is to be at rengthened.

The department has multiuser UNIX system with 17 terminals which is adequate to cater to the needs of other branches requiring Computer Lab. However to cater to the needs of the students of Computer Science and Engs branch, one more Computer system, preferably PC-AT 486 CPU with PC/PC-XT/PC-AT as terminals may be aducci.

4) Workshops -

The aguipment and facilities evailable in the Workshops are generally adequate. However, one number of each of Milling machine and Grinding machine may be added. Also measuring instrument like dial vernier, surface plate and had ght gauge are to be added.

5) Buildings:-

The construction of permanent buildings for electrical machines lab, fluid mechanics lab may be expedited.

6) Furniture -

The laberatories are to be provided with adequate furniture with modern outlocks

The Committee was informed that some of the above mentioned equipments are already ordered for-

The Committee recommends that permission may be granted provisionally to start the II and III 8.E. courses in the respective branches with an intake of 60 students in each branch during 1993-94, with the Stipulation that the above requirements are met in time.
